

USEA Area I Young Riders 2012 NAJYRC Intent to Qualify

If you are planning to qualify for a spot on the 2012 Area I NAJYRC team you must fill out the attached Intent to Qualify form and return it to Area I Young Riders Coordinator, Marion Quigley, 87 Laurel Hill Rd, Northport NY, 11768 , by March 1, 2012. This helps us identify early in the spring season who has thoughts about qualifying so as to help in our planning. There will be a formal application due in May.

Please refer to the "NAJYRC Area I Selection Process" document on the Area I website under "Teams", "Young Riders", "NAJYRC", "Forms", for complete qualifying criteria for NAJYRC CCI* and CCI** teams and information about the team selection process. This document does not get updated until March of the competition year, but the previous year's version can be used as a general guide until the current year's criteria are set by the FEI.

Considerations for NAJYRC Team Selection:

- **Meet FEI qualifying criteria for CCI* or CCI** NAJYRC team competition. • Attendance of a Spring Training Session with Mikki Kuchta is highly recommended**

Attend the mandatory outings. These will be announced as soon as all candidates have identified themselves. We select the mandatory outings based on riders schedules. "NAJYRC Area I Selection Process" document for the process of submitting a request for consideration)

- **Participate in Area I Young Riders fund raising – all team candidates must participate in the fund-raising process to be considered for the team**
- **Horses will be subject to mandatory veterinary evaluation**
- **As with all Area I Young Riders activities, if all other criteria are equal, volunteer activities with Area I Young Riders or other equestrian groups will be considered**
